Cancellations / Refunds / Changes & Sick Days Policy Cancellations (any reduction in the number of sessions you have registered for) must be made by phone no less than 2 weeks before the first day of the session you are cancelling. Refunds will be issued by check and 10% of each cancelled session's fee will be retained by CNC. Please allow 4 – 6 weeks. Changes (switching the sessions you are attending for an equal number of sessions) to your session dates must be made no less than 1 week before the first day of the session you are changing from. A \$20 administrative fee will be charged for each change you make to your original registration. If illness causes a child to miss 3 or more days in 1 week you may make up the days in a later available week in the same calendar year. You may purchase days to complete a week at a prorated cost.
